Volunteers are an important part of our school community. By generously donating time and expertise to our school, volunteers support the learning environment for our students. Our school is committed to ensuring student safety. **With this in mind, anyone who will be working with our students is required to complete a Criminal Record Check (CRC).** If you have a valid CRC from another organization we will accept a copy of that, but otherwise volunteers will have to follow the process outlined below to obtain a CRC free of charge.

• Apply online for a **Criminal Record Check** at https://justice.gov.bc.ca/eCRC/home.htm. Use our school's access code: 7ZAHHYE8E6.* Your Criminal Record Check will be sent directly to the school and it usually takes 10 days to 2 weeks. Please make note of the Reference Number you are given when you complete the CRC application or print off the sheet that confirms you have applied and give a copy to the Colquitz office. (Please note that you will be asked a number of questions relating to banking etc. This is not a credit check - it is just the best way to determine that you are who you say you are).

Criminal Record Check applicants who do not have a credit history of at least six months or have not been living in Canada for at least two years will need to get a Volunteer Letter from the school office to take to the municipal police department to get a CRC from them.

* The Criminal Record Review Program verifies identities through an Electronic Identity Verification (EIV) process. IT IS IMPORTANT TO KNOW THAT THE CRIMINAL RECORDS REVIEW PROGRAM IS NOT RUNNING A CREDIT REPORT; IT IS ONLY USING THE EIV TO VERIFY THE APPLICANT'S IDENTITY AND TO MAKE SURE THE PERSONAL INFORMATION CONTAINED IN THE CRIMINAL RECORD CHECK FORM IS ACCURATE. NO INFORMATION FROM THIS PROCESS IS RETAINED OR STORED BY THE CRIMINAL RECORD CHECK PROGRAM.


If you are **not planning to drive** any of our students the only forms we require for volunteers are the CRC and the completion of a one page School Volunteer form that you can get from the office.

If you are planning to drive any child other than your own, you are required to complete a **Criminal Record Check (CRC) and a Driver's Abstract.** If you can help with driving students please:

Complete our school's 2-sided "Volunteer Driver Form" & "School Volunteer Form," and provide us with a copy of your Driver's License and Vehicle Insurance. \$1,000,000 Third Party Liability is required to drive for the school.
